FROM A LETTER OF RABBI MOSHE TEITELBAUM RABBI OF SHIGET AND ITS DISTRICT TO R, PINCHAS HALPERT.

NO DATE, APPARENTLY IN 1945, or 1946,

From shiget there were thre transports. Your parents your father Rabbi Yecheskel Halpert, of blessed memory ''May Hashem avenge his blood' and your Saintly Mother, peace to her memory. Went with the second transport and arrived in Auschwitz on the eve of Saturday 22 of Iyar, before evening and were Killed in the night of Saturday 28 of Ijar,. For those wich are definatly known we stated Fre Tanzeit for the day in which they arrived in Auschwitz to recite Kaddish, and learn Mishnajot, and the like.

I gave your letter to your brother in law MR JOEL Fishman and he certainly wrote you about the situation in your Family. Only from ''Honorable JOSEF STERN of blessed memory ''Hashem should avenge his blood'' one daughter was left.

After the war i went back to Shiget hoping to find somebody from my Famillic but nobody survived i was 15 years old i stajed with other 4 young girls together. Rabbi MOSES Teitelbaum was the Rabbi of the city he never asked us or was interested what our future will be. My hope was renewed when i heard that Rabbi JOEL Teitelbaum has survived the war and i decidet to to abide by the wish of my parents and at 16 years i went to the city of Satmar and when i turned 17i got Married there to my Husband a student of Rabbi Joel for 6 years before the war.

In 1950 dec. we came to New York, to be near floob! Joel we became members right away on the wishes of the congragation, my oldest son born in 1948 was in 1951 from the first students in the YEShiva of Satmar.

The present Rabbbi Moses Teitelbaum was appointed by Sender Deuch without elections he did not have the authority to give him that pover, his first step was to break the by laws, of the religious court, he trou aut some old Rabbis and appointed his Rabbis some with qestionable backraunds, and breaking the by laws of electing new members.
