States Position of Presidium Re Kashruth In Los Angeles and Debars Chaim I. Etner From Asserting Further Authority.

(STATEMENT)

"I have known the man Rabbi Chaim I. Etner for many years, but not as a Rabbi. I have known him in other fields of endeavor including that of fund collecting in which latter capacity I know of many sordid facts in the past.

"In the history of the Agudas Harabbonim (Union of Orthodox Rabbis) no Rabbi has gone so far in violating the laws of Kashruth . . . I do not understand how he ever became a member of the Agudas Harabbonim and this has been rectified in that he has been expelled from membership. I further declare that he is "asserted" as a Rabbi; his Hechsher is no Hechsher and his declaring an Issur is no Issur. No one should ask him a Shaloh (inquiries pertaining to ritual observances). Shoachim should not show him their chalofim (slaughtering knives).

"This Issur applies to Etner's associates in the so-called Beth-Din of Haradim, butcher shops and poultry markets who remain with him and the so-called Beth Din.

"I also strongly admonish all other Rabbis against giving Etner and the Haradim any moral or other support in any matter pertaining to Kashruth.

"The only recognized Rabbinical body over matters of Kashruth in all its phases is the Vaad Harabbonim headed by Rabbi O. Zilberstein."
